Principle 1: Perceivable – information and user interface components must be presentable to users in ways they can perceive.

(Refer to Guideline 4.1 for additional requirements for controls and content that accepts user input.) • Time-Based Media: If non-text content is time-based media, then text alternatives at least provide descriptive identification of the non-text content.
